MSNCB knows that you care how information about you is used and shared, and we appreciate that you trust us to do so carefully and sensibly. MSNCB has developed this statement on privacy to help MSNCB Website users understand how any personal information we collect is used.

What information does MSNCB collect from you?

Generally, visitors to the MSNCB Website are not asked for any identifying information, however, we collect aggregate information on what pages visitors access or visit.

Information volunteered by the visitor during but not limited to account registration, contact request form submission, certification application, product order, or email newsletter subscriptions, may include your name, email address, mailing address, phone number, employer, last 4 digits of your social security number, credentials, password, demographics, payment information, and other information of those who communicate with us via email, mail and/or phone.

Our systems, and the systems of partners we use to fulfill services for you, may also use automated means to collect information about you, your computer or other device used to access our services. Some of the types of automatically collected information may include: network or Internet protocol address and type of browser you are using (e.g., Chrome, Safari, Firefox, Internet Explorer), the type of operating system you are using, (e.g., Microsoft Windows or Mac OS), the name of your Internet service provider (e.g., Comcast, Verizon or AT&T) and domains used by such providers, device settings, browser settings, the web pages of the services you have visited, sites visited before and after you use our services, the type of handheld or mobile device used to view the content (e.g., iOS, Android), location information, and the content or advertisements you have seen and/or clicked.

Cookies are used to both gather the automated data mentioned above and sometimes to provide a means of managing your experience during your visit (ensuring you are logged in and receiving the content appropriate to

How do we use the information we collect?

The information we collect is used to:

- process applications and fulfill product requests
- improve the content of our Website
- communicate with our applicants and certificants
- announce relevant products and services

MSNCB uses the information collected from Website visitors to communicate MSNCB updates and recertification information. MSNCB certificants and candidates may receive mailing, email, or telephone contact from us with information regarding transaction information, new products and services, or to obtain your input on MSNCB matters.

Application information for certification such as partial social security number, RN license, and employer is considered confidential and is not shared with ANY outside party. It is used only by MSNCB, and Prometric testing services for certification processing purposes.

If you are not an MSNCB certificant, do not wish to receive such contact, and would like to be removed from our database, please let us know by calling or writing us at the above contact information. If you are certified through MSNCB, we need to maintain your postal information, and email address in order to fulfill our obligation to you as an MSNCB certificant and therefore must keep your information in our database for six years.

We also share the information with our affiliated organizations to help them contact *MSNCB applicants and certificants* for marketing purposes. All individuals with an MSNCB record can choose to opt-out of any communications at any time by accessing their record or contacting MSNCB. We do not sell your information to third parties.

Updating or Correcting Your Information

Upon request we can provide site visitors with access to information that we maintain on them. This may include unique identifier information (e.g., customer number, email address), transaction information (e.g., dates on which customers made purchases, amounts, and types of purchases), and contact information (e.g., name, address, phone number).
